Employment Benefit (One-Time)

A one-time \$900 benefit will be administered through the Red Cross and will help to bridge the time between when people lose their employment or close their business on or after March 15, 2020. Tenants

The rights of landlords under section 19 of the Residential Tenancies Act to require tenants to vacate for non-payment of rent, and the authority of residential tenancies officers under section 22 of that act to evict tenants for the same reason, are suspended, until May 31, 2020.

Student Loans

NB Low Income Senior's Benefit

To be eligible for the \$400 benefit, a person must have been a resident of New Brunswick on Dec. 31, 2019, and have received one of the following federal benefits under the Old Age Security Act: Guaranteed Income supplement; Allowance for Survivor Program; or Allowance Program. Provincial Drug Coverage

Effective immediately, and for the duration of the emergency, patients with drug coverage under New Brunswick's public drug plans will only be responsible for the initial co-payment on a prescription fill or refill. For example, a patient with a 90-day prescription will only have a co-payment for the first 30-day fill. There will be no co-payment required for the second and third 30-day fills on the same 90-day prescription. This applies to all New Brunswickers that are on the public drug plan, including many seniors and low-income individuals.

Atlantic Canada Opportunities Agency

Waiving Late Penalties on Property Taxes

Though business property taxes must be paid by May 31, late penalties will be reviewed on a case-by-case basis to see if the penalty can be waived due to undue financial challenges, such as having to close a business due to COVID-19.

Deferring Interest and Principle Payments on Provincial Loans

As an immediate measure, and on a case-by-case basis – the Government of New Brunswick will defer loan and interest repayments for up to six months on existing provincial loans. This support will enable businesses to have immediate relief if they are experiencing difficulties as a result of COVID-19. This assistance is available, on a case-by-case basis, to any business that has a loan with an existing Government of New Brunswick department. The deferral can be requested by contacting the department that issued the loan.

Support for Small Business

The Government of New Brunswick will provide working capital to support small businesses. Loans will be up to \$200,000 and will help companies respond to challenges associated with COVID-19. Opportunities New Brunswick will work with a trusted partner to administer the application process. Updates for April 7:

Loans for working capital now available

Small, medium and large employers in New Brunswick whose businesses have been impacted by COVID-19 can now apply to the provincial government for loans for working capital. The new loans are to support New Brunswick-based companies. A total of \$50 million has been allocated for two distinct loan programs for working capital.

FCC AgriSpirit Fund

Do you have a project that will enhance lives or contribute to sustainability in your rural community? The FCC AgriSpirit Fund may provide between \$5,000 to \$25,000 to projects that qualify in a city, town or Indigenous community with fewer than 150,000 people. Update: Application deadline extended to April 15, 2020. First Nations are eligible up to \$25,000.

Types of Projects considered:

Capital projects – construction or upgrades to a hospital, medical centre, childcare facility, rink, sportsplex or the purchase of fire and rescue equipment.

Sustainability projects - upgrades to heating and cooling systems in a community building, installing new windows in a recreation centre or purchasing capital items for a recycling facility.
